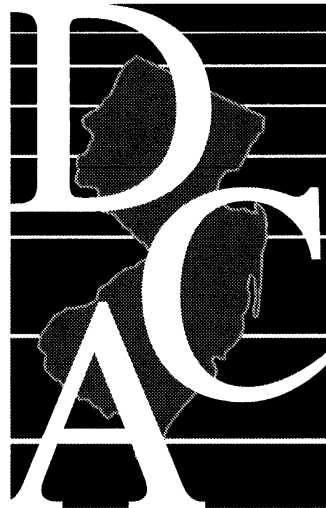

FISCAL YEAR: FROM JANUARY 1, 2012 TO DECEMBER 31, 2012

WHEREAS, the Annual Budget and Capital Budget for the West Windsor Township Parking Authority for the fiscal year beginning, 1/01/12 and ending, 12/31/12 has been presented before the governing body of the West Windsor Township Parking Authority at its open public meeting of October 12, 2011; and

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$1,040,000, Total Appropriations, including any Accumulated Deficit if any, of \$721,093 and Total Unrestricted Net Assets utilized of \$32,520; and

WHEREAS, the Capital Budget as introduced reflects Total Capital Appropriations of \$5,274,500 and Total Unrestricted Net Assets planned to be utilized as funding thereof, of \$424,500; and

WHEREAS, the schedule of rates, fees and other charges in effect will produce sufficient revenues, together with all other anticipated revenues to satisfy all obligations to the holders of bonds of the Authority, to meet operating expenses, capital outlays, debt service requirements, and to provide for such reserves, all as may be required by law, regulation or terms of contracts and agreements; and

WHEREAS, the Capital Budget/Program, pursuant to N.J.A.C. 5:31-2, does not confer any authorization to raise or expend funds; rather it is a document to be used as part of the said Authority's planning and management objectives. Specific authorization to expend funds for the purposes described in this section of the budget, must be granted elsewhere; by bond resolution, by a project financing agreement, by resolution appropriating funds from the Renewal and Replacement Reserve or other means provided by law.

NOW, THEREFORE BE IT RESOLVED, by the governing body of the West Windsor Township Parking Authority, at an open public meeting held on October 12, 2011 that the Annual Budget, including appended Supplemental Schedules, and the Capital Budget/Program of the West Windsor Township Parking Authority for the fiscal year beginning, 1/01/12 and ending, 12/31/12 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the said Authority's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

BE IT FURTHER RESOLVED, that the governing body of the West Windsor Township Parking Authority will consider the Annual Budget and Capital Budget/Program for adoption on December 14, 2011.

The 2012 operating budget represents an increase of \$28,950 (6.1%) increase over the 2011 operating budget.

2. Complete a brief statement on the impact the proposed Annual Budget will have on Anticipated Revenues, especially service charges and on the general purpose/component unit financial statements. Explain significant increases or decreases, if any.

The 2012 operating budget will not require any change in fees. The Authority increased parking fees at the beginning of 2007. That increase was adopted to provide funds for future expansion of the parking facilities in the West Windsor Township lots.

3. Describe the state of the local/regional economy and how it may impact the proposed Annual Budget, including the planned Capital Budget/Program.

The parking lot is currently sold out of permits and expects this condition to continue in the future. The Authority is studying ways available to increase parking capacity in the future and anticipates the construction of a new lot in 2012.

4. Describe the reasons for utilizing Unrestricted Net Assets in the proposed Annual Budget, i.e. rate stabilization, debt service reduction, to balance the budget, etc.

Unreserved assets will be used to maintain current rates and finance future capital projects.
